

5. FIREFIGHTING MEASURES

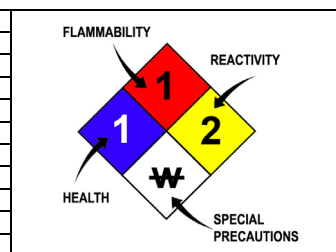
